

Village Board Minutes, July 2, 1979

The regular meeting of the Sleepy Hollow Corporate Authorities was called to order on July 2, 1979 at 7:35 PM by President Carol Schoengart. Roll was called and answered as follows: Mountjoy, Peterson, Thomas, Roberts, Zhe, Schoengart, present. Milz absent. Also present were Clerk Pofahl, Treasurer Scott, Chief Bradley, Engineer Anderson, Plan Commission Hohner.

Mrs. Peterson, moved to accept the minutes, second by Roberts, motion carried by voice vote.

Treasurer's report: Cash balances--General Funds, \$127,040.56; Revenue Sharing Funds, \$3,944.86; MFT funds, \$32,667.47; Road Bond Funds, \$27,658.99; Total: \$191,311.88. Cash Receipts--\$80,585.68. Bills payable--\$2,501.70.

Mr. Mountjoy moved to accept the Treasurer's report, second by Mrs. Zhe, roll call: Mountjoy, Peterson, Roberts, Thomas, Zhe, aye. 0 nays, 1 absent.

Mr. Mountjoy, moved to donate \$100 to the DuKane Council, second by Mrs. Peterson, roll call: Mountjoy, Peterson, Roberts, Thomas, Zhe, aye. 0 nays, 1 absent.

Mr. Thomass, moved to authorize the Police Dept. to close Thorobred Lane between Bullforg and Winmoor on July 4 second by Mr. Roberts, motion carried by voice vote.

The road work contracts have been sent to Curran Contracting for their signatures.

Mr. Roberts moved to allow Mr. Kopetsky to hold his office picnic in Sabatino Park on August 25, second by Mrs. Zhe. Motion carried by voice vote.

Commonwealth Edison will install electricity in the pavillion at a cost of \$269, the Service Club will pay the cost. The backstop in Sabatino Park cost \$1,297, Village will pay.

Mr. Mountjoy moved to raise Bob Naaf's salary to \$1,000 per month as of July 1, 1979, second by Mr. Thomas, roll call: Mountjoy, Peterson, Roberts, Thomas, Zhe, aye. 0 nays, 1 absent. A part time man has been hired for the Road Dept. at a salary of \$3.25 per hour.

Bid offers on the car and truck will be opened and decided on July 16.

Mr. Roberts moved to adjourn, second by Zhe, meeting adjourned, 9:40 PM.
