Village Board, February 4, 1980

The regular meeting of the Village of Sleepy Hollow Corporate Authorities was called to order by President Schoengart on February 4, 1980 at 7:40 PM at the Fire Station. Roll was called and answered as follows: Milz, Peterson, Roberts, Thomas, Zhe, Schoengart, present; Mountjoy absent. Also present were Clerk Pofahl, Treasurer Scott, Chief Bradley, Engineer Anderson, Plan Commission Hohner.

Mr. Milz moved to accept the minutes of the previous meeting, second by Roberts, motion carried by voice vote.

Treasurer's report: Cash balances--GeneralFunds, \$52,015.40; Revenue Sharing Funds, \$808.86; MFT Funds, \$12,439.91; Road Bond Funds, \$33,477.19; Total: \$98,741.36. Cash received, \$34,795.91. Bills Payable, \$1,520.03. Mr. Milz, moved to accept the treasurer's report and pay the bills presented, second by Peterson, roll call: Milz, Peterson, Roberts, Thomas, Zhe aye. O nays, 1 absent. Mr. Milz moved to pay the Samelson, Knickerbocker and Schirott bill for \$832.50, second by Roberts, roll call: Milz, Peterson, Roberts, Zhe, aye, Thomas abstain, 1 absent. O nays.

The Clerk presented Audit Report #15, MFT funds for 1978.
