Board Minutes April 21, 1980

The regular meetin g of the Sleepy Hollow Corporate Authorities was called to order by President Schoengart at 7:40 PM on April 21, 1980. Roll was called and answered as follows: Milz, Mountjoy, Peterson, Roberts, Thomas, Zhe, Schoengart present. Also present were Clerk Pofahl, Treasurer Scott, Attorney Knickerbocker, Engineer Anderson.

Mrs. Peterson moved to accept the iminutes of the previous meeting, second by Zhe, motion carried by voice vote.

Treasurer's report: Cash received, \$7,939.97; Bills payable, \$5,202.87; Fund balances, General Funds, \$21,489.79; Building Funds, \$30,282.64; MFT Funds, \$17,806.29; Revenue Sharing Funds, \$3,995.86; Road Bond Funds, \$34,882.36; Total, \$108,456.94. Mr. Roberts moved to accept the Treasurer's report and pay the bills, second by Thomas, roll call, Milz, Mountjoy, Peterson, Roberts, Thomas, Zhe, aye.

Mrs. Schoengart reported that Mr. Hohner will resign as of April 30 from the Planning Commission due to a move to Arizona. She thanked and commended him for his many years of dedication and hard work on behalf of the Village.

Mr. Roberts moved to pass Ordinance #4-38-1 granting a variance to Mr. and Mrs. Engel to construct a patio fence with dimensions different from those specified in the Zoning ordinance, second by Milz, roll call, Milz, Mountjoy, Peterson, Roberts, Thomas, Zhe, aye.

Mrs. Schoengart began discussion of the agreed order by reading a statement detailing the background of the siutation. Each Board member then stated his/her opinions. Parker McMahon representing Hickory Hollow residents then presented a petition stating the objections of residents of Hickory Hollow, he then read a statement detailing the objections, and proposing several alternatives. The proposals will be sent to the Plan Commission for their study. A public hearing will be held sometime prior to May 30.

The drainage problem on Hillcrest and Rainbow was discussed. Mrs. Zhe moved to authorize work to be done to correct the problem not to exceed \$40 00 second by Milz, roll call: Milz, Mountjoy, Peterson, Roberts, Thomas, Zhe, aye.

The Attorney requested an executive session to discuss acquisition of property.

Mr. Bohanek representing the Service Club requested permission to use the field next to the Fire Station to set off the fireworks on July 4, 1980. Mrs. Zhe moved to approve use of the field West of the Winmoor Extension for the fireworks on July 4, 1980, second by Milz, motion carried by voice vote.

A Revenue Sharing Use hearing will be held on May 5, 1980 at 7:15 PM.

Mini bikes were discussed, and the matter was delegated to the Police Committee.

Mr. Milz moved to authorize the Clerk to prepare an ordinance rescindin g the "Cat" ordinance, roll call: Milz, Peterson, Roberts, Zhe, aye; Thomas, Mountjoy nay.

Mrs. Zhe moved to authorize a temporary liquor license to the Service Club for July 4, 1980; second by Roberts, motion carried by voice vote.
