Public Hearing on Cable TV

Village Board Meeting

March 16, 1981

President Peterson called to order the regular meeting of the Sleepy Hollow Corporate Authorities at 8:25 PM mn March 16, 1981. Roll call: Peterson, Grisolia, Mountjoy, Roberts, also Clerk Pofahl, Attorney Knickerbocker, Chief Bradley, Attorney Anderson. Thomas, Zhe, Milz absent.

Mr. Grisolia moved to accept the minutes of the previous meeting, second by Roberts, motion carried by voice vote.

Treausrer's report: General, Bills = \$4456.13, receipts, \$6420.97. Mr. Roberts moved to accept the Treasurer's report and pay the bills, second by Mountjoy, roll call: Grisolia, Mountjoy, Peterson, Roberts, aye. 3 absent.

Water Dept.: = Bills, \$8294.35; receipts, = \$2882.93. Mr. Roberts moved to accept the Treasurer's report and pay the bills, second by Mountjoy, roll call: Grisolia Mountjoy, Peterson, Roberts, aye. 3 absent.

MEETINGS: April 6, 7:00 P prior to Board Meeting, Revenue Sharing Use hearing, published in Free Press.

April 13, Entire Board, Canvass votes, budget workshop. 7:30 P. May 13--Entire Board--7:30 P, at Gilberts, jurisdictional boundaries.

Fred Pfau of the Fire Dept. reported that the Fire Dept. will inspect all fire hydrants and identify those which are not working properly.

Al Treml of the Service Club requested permission and possibly the lease of land from the Village to construct a storage shed for equipment and supplies owned by the Service Club. Mr. Roberts and Mr. Mountjoy, will discuss the matter.

Mr. Roberts moved to authorize the Attorney and Engineer to investigate easements on Mr. Storms property for the construction of the cross valley water main, to draw up the necessary documents to obtain the easement, and prepare documents to go for bids on the work,

bids will be received until April 17, they will be opened at 3:00 PM at the office of CMT in Aurora, Rob will attend, second by Grisolia, motion carried by voice vote.

Me.Anderson presented the MFT proposal for 1981. Mr. Roberts moved to pass Resolution # 100 which proposes spending of \$74,000 for road work in 1981, second by Grisolia, roll call: Grisolia, Mountjoy, Peterson, Roberts, aye. 3 absent.

Mrs. Peterson directed the Zoning Board to consider amendments to the Zoning Ordinance in the areas of building windmills for generating electeicity, commercial trucks, one ton trucks, building earth, solar and dome houses.

Mr. Mountjoy moved to hire Ed Starzyinski at \$4.00 per hour for the summer months to do mowing, second by Roberts, roll call: Grisolia, Mountjoy, Peterson, Roberts, aye.

Mr. Mountjoy moved to hire Richard Younger at \$5.00 to work part time on roads, water, and building, second by Grisolia, roll call: Grisolia, Mountjoy, Peterson, Roberts.

Mr. Grisolia moved to adjourn, second by Roberts, meeting adjourned at $10:00\ PM$
