Revenue Sharing Proposed Use Hearing and Regular meeting of the Sleepy Hollow Board

The Revenue Sharing Proposed Use Hearing was called to order by Mrs. Matthews in the absence of Mrs. Peterson on March 7, 1983 at 7:25 PM in the Fire Station. Notice had been published in the Free Press Newspaper on February 23, 1983. Present were Mr. Grisolia, Mr. Roberts, Mr. Treece and Treasurer Panning and Clerk Pofahl. Expected revenue for EP 14 is \$9277,  $\frac{1}{2}$  of which be received in FY1984. Carole Ziegler of Family Service of Dundee gave a presentation and requested \$500.
