Village Board Minutes April 18, 1983

The regular meeting of the Sleepy Hollow Corporate Authorities was called to order on April 18, 1983 at 7:40 PM by President Peterson. Roll call: Grisolia, Matthews, Roberts, Treece, Peterson, Rabe and Thomas arrived 7:55 PM. Also present were Clerk Pofahl, Treasurer Panning, Attorney Knickerbocker.
