Village Board Minutes December 5, 1983

The regular meeting of the Sleepy Hollow Corporate Authorities was called to order by President Peterson on December 5, 1983 at 7:30 PM at the Fire Station. Roll call: Cook, Matthews, Thomas, Treece, Rabe, Peterson; also Clerk Pofahl, Chief Bradley, Treasurer Panning, Attorney Knickerbocker, Plan Comm. Divan.

Prior to the Board meeting there had been a meeting to discuss the <u>appointment</u> to the Board of a <u>new member</u> to fill Mr. Grisolia's term. Marrietta Divan and Ed Moff had been present and a letter from Rob Roberts and Mrs. Divan had been read.

Mr. Treece moved to accept the minutes of the previous meeting, second by Matthews carried by voice vote.

Elgin Sanitary District (ESD) and the Kane County Development Dept. will meet on Dec. 8 at 9:30 AM to discuss upsizing the sewer pipe from W. Dundee to Elgin, Matthws will attend. Dec. 9 at 9:30 AM at the County Mighway Dept. building, Treece will attend; discussion on Randall Rd. access to Northwest Tollway. Peterson will attend DBPA meeting on Dec. 14. No Plan Commission meeting in December.

Mrs. Peterson appointed Mr. Roberts to the unexpired term vacated by Mr. Grisolia term ends 1985. Mr. Rabe moved to adjourn to Executive session, second by Cook, carried by voice, 7:35 PM. Reconvene at 7:50 roll call: Cook, Matthews, Thomas, Treece, Rabe, Peterson present. Mrs. Matthews moved to concur in the appointment of Mr. Roberts, second by Treece, roll call: Cook, Thomas, no; Matthews, Treece, Peterson yes; Rabe abstain.

Mrs. Peterson reappointed Barb Ferguson, Rich Reedy and George Smith to the Planning Commission for 3 years, terms expire 1986. Mrs. Matthews moved to concur, second by Cook, earried by voice.

Re: Dahlgren property at Rt. 72 and Locust; he wants us to mow the lot and he'll allow the Sleepy Hollow sign to remain. Mr. Rabe moved to mow the lot enough times to keep it looking nice and advise the owner there will be no compromise on past or future actions, Matthews second, carried by voice, 2 no. Attorney will write.

Pofahl will attend <u>DuKane Valley Council</u> workshop and lunch on <u>Dec. 15</u> re: Freedom of Information act.

Chuck Behm wans to put a sign up on the corner of Sleepy Hollow Rd. at Rt. 72 identifying the Township Garage, must be 40 feet from road. Treece has plans.

Mr. Rabe moved to pay Radio Shack \$337.70 for two CB/walky-talkys, second by Cook, all present aye.

Mr. Cook moved to approve paying the water bill from Elgin due the end of December not to exceed \$6,000, second by Matthews, all present aye.

Mr. Rabe moved to split the Radio Shack bill equally between Roads, Water, and Parks, second by Cook, roll call: Cook, Matthews, Rabe, aye, Treece, no.

Matthews moved to pay \$98,950 from Road Improvement Fund, second by Rabe, roll call:

Mr. Rabe moved to go on the reimbursement program for <u>Unemployment Insurence</u> provided Mr. Peterson received encouragement from Mr. Escalante or Mr. Sommers. second by Matthews, carried by voice.

Mr. Berliant will attend the meeting in February regarding Bohanek's creek. Don Griffin will attend the second meeting in January.

A date for the Police Committee meeting will be set soon.

A letter to residents on wells who must connect to the Village system will go out Dec. 6.
