Thomas moved with a second from Cook to approve the minutes from July 15, 1986 except that said motion should read "... interest on the total principal amount of bonds for 1985..." Carried by voice.

KANE COUNTY HIGHWAY DEPARTMENT Representative Terry Heffron came before the Board to request a donation from the Village for the Randal Road I-90 Interchange. Construction is set for next spring. It will be a half diamond with on and off ramps from theEast. It will cost 4 to 4 1/2 M. The Toll Highway will put up 3M- the County will put up \$400,000, the City of Elgin will put 'up to' \$300,000. They need \$100,000 more. They would like the Village to donate \$10,000 over a 2 year period.

## OPEN TO PUBLIC

- 1) Rugby Club presented their game schedule for this Fall. Thomas moved with a second from Cook to approve a 1 day liquor license on Oct. 4. Carried by voice. The Club would like to pursue developing the field north of the soccer field.

Shields

- 3) Requested the addition of Timber- from Crane to the end to be repayed; and, it sufficient funds are left, to repaye Van Tassel from Beau Brummel to Beau Brummel Crt.
- 4) Water- Proposed the possibility of interconnection with West Dundee as a back up. Cook felt this was not feasible.

2) Shields reported that if the accounting were changed to a quarterly basis we would pay approximately \$600. We are now paying \$750.

3)put forth comparison costs of the Village of South Barrington and the Village of Sleepy Hollow with respect to road and plowing costs. It was the concensus that more investigation needed to be done. a) Harris would pursue said costs with the S. Barrington Clerk. b) Harris and Shields would come up with a proposal. c) Suggested any savings be put into "roads"

POLICE- 1) In view of the Rainbow Creek, the Trustees agreed the Police should patrol the area at school bus time.

2) Hoff will discuss the matter of the motor bikes within Saddle Club Estates with the Police Dept.

ROADS- Shields moved with a second from Hoff the vacant lot next to the Oppenheims be cut: and on the curves on Sycamore, the weeds be cut to improved the visability of cars going around the corner.

WATER- Trusteesnoted the water ordinance called for a \$50 charge if someone had to tap onto a fire hydrant.
