

VILLAGE BOARD MEETING

AUGUST 7, 1989

MINUTES

The Regular Meeting of the Sleepy Hollow Corporate Authorities was called to order on August 7, 1989 at 7:35PM. Present were Trustees Roberts-Shields-Tennis-Ward; Treasurer Panning; Chief of Police Montalbano; Deputy Clerk Olson; and Village Clerk McKeown.

Roberts App'td President Pro Tem (amended 8.21.89)

- MINUTES** 1. Tennis moved with a second from Shields to approve the Minutes of the July 19, 1989 Regular Session.
2. Tennis moved with a second from Shields to approve the Minutes of the July 29, 1989 Special Meeting.

PRESIDENT Request from Kim Flannigan to serve [REDACTED] beverages at a 5th year reunion for St. Edwards on September 9, 1989. Ward moved with a second from Tennis to approve liquor permit on September 9th from 1 PM to dusk and all participants should be of legal age.

AYE: Ward-Tennis-Shields-Roberts MOTION CARRIED

CLERK 1. We only have 9 bicycle tags left. Officer Friendly will be making an effort to register bicycles this fall so we will need some more. Ward moved with a second from Tennis to buy 500 bicycle tags at \$160.

AYE: Ward-Tennis-Shields-Roberts. MOTION CARRIED

2. Illinois Municipal League Annual Conference is on September 16-18. Please see Clerk to reserve space.

ROADS-PARKS-VILLAGE PROPERTY 1. Shields proposed to use part of the recycling funds to hold a lottery to encourage recycling and put the rest into a reserve account for Village beautification projects. Projects would be subject to approval by the Board. Tennis felt we had agreed the money would go into the General Fund to reduce the tax rate for all.

2. Service Club donated trees to the Village and had them erected in Sabatino Park. Are they eligible to have the donation inscribed on the Memorial Rock? Harney will pursue.

3. A question has been asked as to dredging of Lake Sharon. Roberts pointed out the history of dredging the Lakes and that it was expensive and not a permanent solution. Harney will pursue.

4. Harney should contact Valente to clean out his swale and culvert along Sleepy Hollow Road.

5. Roberts pointed out the heavy rain during the weekend produced about 4 1/2 of water. Drainage in the Village appeared to be good with the exception of Surrey's retention pond. That is being taken care of.

FINANCE 1. Audit is under way and expected shortly.

2. Panning is looking into a back up system for the computer.

WATER 1. A Meeting with Elgin is tentatively scheduled for a

week from tomorrow.

2. Tennis asked the status of the ~~sprinkling ban~~. Concensus of the Board was to await advise from Whiston.

POLICE 1. Amended Intergovernmental Agreement and By-Laws dated July 20, 1989 were presented. This is a result of the meeting between Roberts, Shields, Tuma, Pena and Smith. (see 7/17/89 Minutes page 3 Police #3) Roberts and Shields are satisfied. Roberts noted our representative(s) to 9-1-1 must keep our Board up to date.

It was noted there has been an adjustment in the Law-it now allows the Emergency Board to use the money for anything. Ward moved with a second from Shields to approve the Quad Com amended Intergovernmental Cooperative Agreement dated July 20, 1989.

2. ~~officer~~ Childs prior Police Training has been recognized and accepted.

3. The volume of business done in the front Office requires a part time 25 hour a week permanent ~~office person~~. Person would do general office duty and be cross trained to do Police and Water Duties. Amount is in the budget. Shields moved with a second from Ward to approve hiring of a permanent part time employee for 25 hours a week at a salary not to exceed \$5.50 per hour.

AYE: Shields-Ward-Tennis-Roberts MOTION CARRIED
4. Police Activity Report was presented. Noted that the crime statistics in the Chicago Tribune and local papers show us the lowest rate in Kane. Increase in traffic stops during July is a result of new manpower and the season.

5. Childs will attend Traffic Crash Reconstruction class at no cost to us.

6. Set up a checkpoint at the apartments to check for ~~Village stickers~~. There will be other checkpoints throughout the month.

7. Candidate applicants are in training.

8. Out of 33 new applications taken out 17 have been returned for the next set of part timers.

9. Vacation Policy is confusing. Presented a proposal. All reference to calendar year should be dropped except for paragraph #7. All vacation must be used by December 31 will remain. Tennis moved with a second from Shields Vacation Policy to be changed as proposed for first and fifth paragraphs and continued with the policy all vacation time must be used by December 31 or exceptions as provided in the old vacation policy. MOTION CARRIED BY VOICE.

2. Still no word over the interest problem with West Dundee.


NEW BUSINESS Clerk noted meetings taking place during August:
