EXECUTIVE SESSION

JANUARY 2, 1990

Meeting of the Regular Session adjourned into Executive Session at 9:20PM for the purpose of discussing litigation and personnel matters. Present were President Peterson; Trustees Harney, Roberts, Shields, Tennis, and Ward; Attorney Samelson; Deputy Clerk Olson; and Village Clerk Mckeown.

1. Gilberts has filed suit against Elgin over the annexations on Randall and I-90. The Hearing is tomorrow in front of Dunn who was the Judge in the South Elgin/Elgin Annexation dispute. Samelson wants to see what happens as he had such short notice He has spoken with Roeser, Gilberts' Attorney, and their suit is similar to South Elgin's Samelson would like to be able to file our suit this week. He would like the Board to authorize Peterson to execute any pleadings as necessary. He expects a relatively fast ruling. Dunn's S. Elgin/Elgin decision is based on comprehensive planning. There is a question if this will hold up. FPA is a different issue- it is an administrative instrument afforded by NIPC. Elgin Administrator has not contacted our Committee yet.

Samelson felt we should become independent of Elgin (i.e. water)

3. PROSECUTING ATTORNEY: Peterson talked to Bruce David. were able to come to a rate of \$250 per month. (He had been getting \$125 and wanted \$375) Tennis feels we need to go out for bids. Roberts is concerned how David would view us going out for Peterson pointed out our prior Attorney was not dependable (sometimes he would not show up for Court) and the returns on a prior search were not acceptable. Most of the Trustees wanted to stay with David.

4. Peterson had an "unfriendly" chat with Dick Husted. he would like to sue the Board individually as he feels "we" have done an injustice to the Rte. 72 property owners by annexing them and then instituting a restrictive business zoning ordinance. We can give them water. We cannot attach them to the sewer district as the agreement with W.D. excludes commercial. Roberts felt we could use the "equidistant ruling" with W.D. over the Locust cornfield. Then we could negotiate for sewer for Rte. 72 and Tuckers.

Former Police chief Bradley Lawsuit: It appears the Judge feels Bradley should get something.

 $q\lambda$ He is back in the hospital. The situation does not look good. In view of the whole situation, Trustees felt we could do nothing.

Tennis moved with a second from Harney to adjourn into Regular Meeting adjourned into Regular Session at 10:48PM
