## PUBLIC HEARING

### REMOVAL OF ARCHITECTURAL BARRIERS PROGRAM APPLICATION

June 27, 1994, 7:30 p.m.

Village of Sleepy Hollow, IL.

#### I. Funds available.

For 1994, the states federal Community development Assistance Program allocation is \$42,568,000.00. Each program component has a maximum funding level or grant ceiling. While grant ceilings establish the upper limits that may be requested, individual grants are invited only in amounts commensurate with requirements of the proposed project. Fund availability will distributed as follows:

#### II. The range of activities that may be undertaken.

1. Demolish existing single restroom, floor, and walls; install two (2) new handicap restrooms with Grab Bars and new accessible entry doors along the north side of the Village Hall and close the north side entrance.
2. Remodel roof line and raise roof as required for accessible height to accommodate new entrance on west side.
3. Install new entrance on the west side of the Village Hall and provide access directly from the parking lot.
4. Remodel collector's counter to meet ADA requirements and close off wall areas in the administration area.

5. Plumbing and Electrical work and installation of a new handicap drinking fountain.
6. Remove portion of exterior wall and raise roof as required for accessible height; install new entry door and concrete stoop as required to the meeting room.

-III. The estimated amount proposed for activities that will benefit low and moderate income individuals.

Estimated amount for activities: \$31,750.00

IV. Plans for minimizing displacement as a result of the block grant assisted activities and to assist persons actually displaced.

This project will not displace any person nor require assistance to persons actually displaced.

V. The community development and housing needs.

The Village has not determined community development and housing needs.

VI. Public hearing access by the handicapped.

Village staff will provide assistance to assure access to the public hearing by the handicapped persons.

VII. How and where to access the applicant's CDAP records.

Come to the Village Hall during office hours of 8:00 a.m. to 5:00 p.m. Monday through Friday except Holidays and request access to view the applicant's CDAP records. Call in advance for Village staff assistance to access CDAP records by the handicapped persons.
