- 5. Village Attorney was asked about our agendas and will do only a small amount of research on this issue. Board should try to give Clerk any information available in advance for inclusion on the agenda.

### ENGINEER:

1. The Village Engineer contacted the Kane County Department of Transportation and advised them of our interest in improving the Joy Lane intersection. However, they will proceed no further until the Village makes a motion on this matter. Board discussed and agreed to the widening, but not whether to allow cars to proceed straight from Joy Lane into the development across the street. MOTION PASSED.

## TREASURER:

- 1. Add \$1,430.32 for FICA. <u>CZERNIAWSKI MOVED WITH A SECOND FROM NEMEC TO APPROVE THE DECEMBER 31, 1998 ACCOUNTS PAYABLE IN THE AMOUNT OF \$33,96184. AYE: CZERNIAWSKI, NEMEC, DEBOLT, HARNEY. MOTION PASSED.</u>
- 2. Treasurer Panning distributed a memo on the proposed water rate increases for review by the board. An ordinance will be presented at the next meeting.
- 3. Discussed the proposed changes for sickness disability absence to be included in the personnel policy manual. These changes benefit both the Village and the employees. CZERNIAWSKI MOVED WITH A SECOND FROM DEBOLT TO APPROVE THE CHANGE IN THE PERSONNEL POLICY MANUAL REGARDING SICKNESS DISABILITY ABSENCE. MOTION PASSED BY VOICE VOTE.

#### **ROADS & PARKS**:

- 1. The Service Club has asked the Village to submit the p.o. for the bricks for their Lake Sharon/flagpole project in order to eliminate sales tax. However, this would put the burden of payment for the entire project on the Village and was not the agreement of the Village when this project was first proposed. Our payment of this would also require a change in our appropriations. Trustee DeBolt will discuss this further with the Service Club and report back to the Board.
- 2. Board agreed the snow plowing from the weekend snowstorm was excellent and there have been no complaints.
- 3. Trustee Czerniawski said both lights are out at the Saddle Club entrance, although one may just be buried under snow.
- 4. The open area around the Village Hall was cut and the prairie seed was planted.
