# REGULAR MEETING **MINUTES**

## MINUTES:

HARNEY MOVED WITH A SECOND FROM DEBOLT TO APPROVE THE REGULAR MINUTES OF JANUARY 4, 1999 AS SUBMITTED. MOTION PASSED BY VOICE VOTE WITH MERKEL AND WILLIAMS ABSTAINING.

### PRESIDENT:

- Kane County has been declared a disaster area because of the recent snowstorm. Ellen Volkening will attend a county meeting to determine if we are eligible for reimbursement of any of our costs resulting from the storm.
- TCI cable is merging with AT&T. We must sign a resolution agreeing to this transfer of control and in 2. return will receive \$1,500. DEBOLT MOVED WITH A SECOND FROM HARNEY TO APPROVE RESOLUTION NO. 274 ENTITLED "A RESOLUTION APPROVING THE TRANSFER OF CONTROL OF THE CABLE COMMUNICATIONS FRANCHISE". DEBOLT, HARNEY, CZERNIAWSKI, AYE: MERKEL, WILLIAMS. MOTION PASSED.
- The fire chief has requested that fire suppression and alarm systems be incorporated into our zoning 3. ordinances as requirements for all commercial buildings. This draft ordinance will be submitted to Trustee Harney for comments and to advise KinderCare It should then be forwarded to the village attorney for his review.
- Jay Nollman sent us a letter concerning his easement given for the water main connection. He doesn't feel the drainage is working properly along his property since the work was completed. This was Dundee Township property who has signed off on this restoration work as being proper and complete.
- President Shields, along with residents and a building contractor, viewed a Pulte development off Randall Road in Elgin and filmed the homes under construction to show the lack of quality by Pulte home builders.

#### TREASURER:

- 1. Add \$162 for ICMA and \$75.53 for Mobile Comm. Delete the bill of \$7,200 from Sebastian Contracting for culvert work on Crane Drive. Trustee Williams noted that this was for culvert replacement work that was unrelated to the water main project and should be paid. This is not reimbursable from the bonding company. We will discuss this at the next meeting when our village attorney is present to give more details. CZERNIAWSKI MOVED WITH A SECOND FROM MERKEL TO APPROVE THE WARRANTS OF JANUARY 15<sup>TH</sup> IN THE AMOUNT OF \$75,156.48. AYE: CZERNIAWSKI, MERKEL, DEBOLT, HARNEY, WILLIAMS. MOTION PASSED.
- 2. Financial statements were reviewed. Trustee Czerniawski noted that the crack sealing appears to be over budget because we applied some of last year's monies to this year's project.
- 3. WILLIAMS MOVED WITH A SECOND FROM HARNEY TO APPROVE ORDINANCE NO. 99-3 ENTITLED "AN ORDINANCE AMENDING THE VILLAGE CODE, SECTION 6-3-7B.2b, SECTION 6-3-9B.1, SECTION 6-3-9C.1, SECTION 6-3-9D, AND ADDING SECTION 6-3-9E OF TITLE 6, CHAPTER 3, TITLES-VILLAGE WATER AND SEWER, OF THE VILLAGE OF SLEEPY HOLLOW, KANE COUNTY, ILLINOIS. AYE: WILLIAMS, HARNEY, CZERNIAWSKI, DEBOLT, MERKEL. MOTION PASSED.
- 4. Office computer purchases will be delayed until spring.

#### ROADS & PARKS:

- 1. Building Inspector Joe Prang will be going out to bid for roofing and siding of the Village Hall.
- 2. A couple mailboxes were damaged during the recent snowplowing. Some courts had problems with no place to put the snow that was removed from driveways by private snow plowers.
- 3. The parking lot lighting project was started, but delayed by the snow.
- 4. Resident Sue Bennett has applied for grants for the Lake Sharon project and will keep the Board advised.
- 5. The purchase order for the Service Club project discussed last meeting is for 100 bricks. The Village will pay the bill but immediately be reimbursed by the Service Club.
- 6. The final payment for the MFT project has been made to Curran Contracting.

#### FINANCE:

- 1. We have received a \$2,200 refund from Heinz Engineers for MFT engineering fees.
- 2. Budget papers will be prepared and distributed to trustees soon and this year will include suggested line item dollar amounts. The first budget meeting will be scheduled for March.

- 2. Officer Wilson discussed the new peer jury program in which we will participate with surrounding communities. This is for juveniles who have committed non-violent crimes and is in lieu of the court system. They requested \$200 for the purchase of pagers, photocopying, and other expenses. HARNEY MOVED WITH A SECOND FROM MERKEL TO APPROVE \$200 FOR EXPENSES ASSOCIATED WITH THE PEER JURY PROGRAM. AYE: HARNEY, MERKEL, CZERNIAWSKI, DEBOLT, WILLIAMS. MOTION PASSED.

2. Trustee Harney discussed the position paper for the DuKane Valley Council and will leave a copy for trustee review. She encouraged our participation at the breakfast meetings of the Council which are held on the

second Tuesdays of the month in Batavia.

# EXECUTIVE MEETING MINUTES

The executive session of the Board of Trustees was convened at 9:00 p.m. for the purpose of discussing pending litigation and executive minutes pursuant to §\$2(c)(11) and 2(c)(21) of the Open Meetings Act. - 1. Discussed the Fahy lawsuit. Trustee Harney and Joel Kruse have been personally sued by Mr. Fahy in additional lawsuits and the Board agreed the Village should pay for their defense. They will need to obtain an attorney since there may be a conflict of interest to have Mark Schuster also defend them as well as the village. It is felt these personal suits can be dismissed fairly quickly and easily. Trustee Harney and Mr. Kruse may need to have separate attorneys to represent each of them, again because of a possible conflict between the two of them. A potential defense attorney is reviewing this matter. The Board would like a status report on the Fahy suit from our attorney.
