## ) ZONING COMMISSION:

- 1. Chairman Art Neil said the Board met concerning a zoning amendment resulting from the Dundee Township special use application. A public hearing is scheduled for February 12<sup>th</sup> at 7:30 p.m. (Trustee Getz arrives at 7:40 p.m.) All trustees were encouraged to attend the public meeting if possible.

# PUBLIC BUILDINGS & ENVIRONMENTAL:

The Board discussed the bid specs for the Village Hall janitorial services. It was suggested we obtain bids for a two year contract, rather than one year.

Our current waste pick up service has requested a meeting concerning our contract, which expires 12/31/02 and a meeting will be scheduled. It was questioned whether we are required by statute to go out to bid when this contract expires. The Village Attorney will research this issue and advise the Board.

# **BUILDING & ZONING ENFORCEMENT:**

The gazebo project is still in the works; there may be some action in the spring on this project.

### OLD BUSINESS:

- Mr. Schuster and the Board discussed the issue of Village boundaries and control over our roads exiting onto Route 72 if we do not have jurisdiction on Route 72. Also discussed other boundary roads, including Sleepy Hollow Road. This matter will be brought up for discussion again in the near future.
- The newsletter and resident survey should be approved by the next board meeting. Trustee Ziemba will draft an information article for the newsletter regarding the pension referendum.
- Board discussed the drainage/easement matter in Deer Creek. We have not yet determined who is responsible for maintenance of this area. The easement and the drainage/creek area do not match and one will need to be moved into the other, which will involve substantial survey expenses, and recording fees. CMT, the previous Village engineers, may have the information indicating who is responsible for maintenance. The Board asked Mr. Schuster to contact CMT to request a search of their records after advising President Pickett of a cost estimate for their services.
- President Pickett will draft an addendum to the personnel manual concerning overtime in the Public Works Department.

# **NEW BUSINESS:**

Trustee Ziemba will review the current Village stickers and animal tags in terms of a possible price increase to residents this year.

The executive session of the Sleepy Hollow Board of Trustees was convened at 9:35 p.m. for the purpose of discussing pending litigation pursuant to §2(c)(11) of the Open Meetings Act. In attendance were President Pickett; Trustees Getz, Grom, Merkel, Morris, Rzonca, and Ziemba; Village Engineer Heinz; Village Attorney Schuster; and Clerk Olson.

- 1. West Dundee v. Sleepy Hollow. Mr. Schuster explained the proposed Settlement Agreement. The consensus of the Board was to settle this matter as described in the Agreement. The only change to the proposed Agreement should be a modification to paragraph #9, which will be written by Mr. Schuster and suggested to attorneys for West Dundee for approval. The purpose of the suggested modification is make clear that this settlement will not affect the Village's existing waste water agreements with West Dundee. Mr. Heinz was advised of the requirements of the Agreement concerning installation of the meter at the former Home Life Property and creation of a map showing all tap-ons in the Village's wastewater transmission system.
- 2. <u>Pulte Home Corporation v. Sleepy Hollow.</u> The Judge denied the Village's motion to dismiss Pulte's Petition for Damages. Mr. Schuster and Mr. Kurnik expect to request leave to appeal the decision to the Appellate Court. (Mr. Heinz leaves the meeting at 9:55 p.m.) The Board and Mr. Schuster discussed in general how the case may proceed. The next pending court date is February 21<sup>st</sup> for case management conference.
