There was some concern about unrestricted hours of illumination for future commercial development, but it was agreed that can be addressed at the time of those developments. COMMENTS FROM THE PUBLIC:

- Howard Moulton, a long time resident of Sleepy Hollow Road read a statement about Sleepy Hollow Road and the dangerousness of bicycles on that road.
- 2. Beth Smith of Sleepy Hollow Road spoke out against a bike path on Sleepy Hollow Road and asked the Board to follow the wishes of the residents in this matter.
- 3. Kevin Thompson of Crane Drive expressed his concerns about altering Sleepy Hollow Road in any way.
- 4. Mona Auer of Sleepy Hollow Road read a letter from Mr. Braasch of the Dundee Township Highway Department stating his opinion on the safety of Sleepy Hollow Road. She also gave the Village two more resident signatures asking that Sleepy Hollow Road be removed and read a statement objecting to the proposal to include that road on the regional bike plan.

John Plosila of Maria Court noted that the residents are not against bike riders but against a possible bike

path being developed along Sleepy Hollow Road in the future.

- 6. Matt Mayer of Beau Brummel again asked about purchasing the Village easement adjacent to his property that abuts the Pulte development. He also spoke in favor of the police pension and retaining the trees along Sleepy Hollow Road.
- 7. Mike Kowalski of Sleepy Hollow Road has observed the traffic on Sleepy Hollow Road for several months and noted that many trucks are traveling on this road and many drivers are exceeding the speed limit. He is also against a bike path on the road and asked the board to give this matter more consideration.
- 8. Walt Heffron of Van Tassel Road had several comments and questions about the village survey, noted that the Village website has outdated and incorrect information, and commented on the recent newspaper article by the local bicycle club.
- 9. Michael Pugliese of Sharon Drive, a local paramedic, spoke in favor of the police department and expressed his opinion from his experiences as a paramedic that Sleepy Hollow Road is dangerous for bicycles.
- 10. David Williams of Jamestowne Road spoke against Sleepy Hollow Road being considered as a bike path and felt the road should not be widened for any reason.

PARKS, ROADS & STREETS:

- 1. We received two bids for landscaping services. GROM MOVED WITH A SECOND FROM MORRIS THAT WE APPROVE THE TWO YEAR MOWING AND LANDSCAPING BID OF \$25,444 FROM M&H LANDSCAPING FOR FISCAL YEARS 2002/03 AND 2003/04, CONTINGENT ON RECEIPT OF A CURRENT CERTIFICATE OF INSURANCE.
