COMMENTS FROM THE PUBLIC:

- 1. Mona Auer of Sleepy Hollow Road passed out copies of a petition signed by all but two residents of Sleepy Hollow Road, requesting that the road be removed from the bike path, and a letter from the Dundee Township Highway Commission concerning the safety of the road. Mrs. Auer also read a statement on why the road should be removed from the proposed bike path map.
- 2. Hugh McGowan of Elgin read a letter he wrote to the newspaper with his objections to keeping Sleepy)Hollow Road on the proposed bike path map.
- 3. Walter Heffron of Van Tassel asked about the opening of the Homemakers store and was advised that it is scheduled to open at the end of the month.
- 4. Cody Zeh of Willow Lane presented a petition signed by over 100 people in support of a skate park in Sleepy Hollow. He is looking for donations of building materials from local vendors and asked the Board to consider building a park. This was referred to Trustee Grom.

PARKS, ROADS & STREETS:

- 3. GROM MOVED WITH A SECOND FROM MERKEL TO HIRE KEVIN TOMASIEWICZ AS A PART TIME SUMMER EMPLOYEE AT \$7.50 PER HOUR, SUBJECT TO PHYSICAL TESTING. AYE: GROM, MERKEL, GETZ, MORRIS, RZONCA, ZIEMBA. MOTION PASSED.

FINANCE:

Trustee Ziemba asked about a pending balance due from a resident. We are waiting for West Dundee authorization to connect the drain tile under Locust which will complete this matter and we can then expect payment from the resident.

The engineering water improvements agreement will be discussed at the next board meeting.

It was also suggested we confirm that we are adhering to state statute by offering this benefit.
