- 2. Two engineering estimates were submitted for work at Sabatino Park to fulfil ADA requirements. The Finance Committee recommends Option 2 for \$23,859. ZIEMBA MOVED WITH A SECOND FROM WIND TO APPROVE OPTION 2 FOR SABATINO PARK FOR ADA COMPLIANCE FOR FISCAL YEAR 2010. MOTION PASSED. There may be grants for this type of project. The boy scout may be able to do the ramp portion of this project for his Eagle Scout badge.
