#### **MINUTES**

1. Trustee Ziemba distributed and briefly discussed the seven month financial statements; the water fund is doing better than expected as is the sewer fund.

# WATER AND SEWER

1. The residents will see a water rate increase due to Elgin's increase to the Village. Elgin is anticipating substantial increases over the next few years. Seiler moved with a second from Getz to approve Ordinance No. 2010-1 entitled "An Ordinance Amending the Village Code, Section 6-3-9B.1, Title-Village Water and Sewer of the Village of Sleepy Hollow, Kane County, Illinois" increasing the rate from \$5.97 to \$6.33 per 1,000 gallons. Aye: Seiler, Getz, Finney, Fudala, Wind, Ziemba. Motion passed.
