The regular meeting of the Sleepy Hollow Corporate Authorities was called to order at 7:30 p.m. at the Sleepy Hollow Village Hall. Board members in attendance were President Stephan Pickett and Trustees Scott Finney, Dennis Fudala, Joseph Nemec, Jeff Seiler, and Donald Ziemba. Trustee Russell Getz was absent. Also in attendance were Director of Finance Ellen Volkening and Police Chief James Linane.

MINUTES

1. Ziemba moved with a second from Seiler to approve the Village Board Meeting Minutes of December 7, 2015. Motion passed unanimously.

PRESIDENT

- President Pickett reviewed the history of a resident petition for a zoning text amendment to permit an outbuilding on his 10+ acre parcel on the south end of Sleepy Hollow Road. The Zoning Board recommended denial and the Board approved their recommendation at its November board meeting. Property owner Joseph Valente was not present at that meeting but was present tonight with his attorney, Jim Bolz, who distributed a plat of survey and drawings of the proposed outbuilding that will be used for equipment storage. Mr. Valente, a long time resident of Sleepy Hollow, also owns an adjacent parcel of an additional 10 acres. The proposed building would not be visible from the road or any adjacent property. The options for permitting this structure were briefly discussed. Seiler moved with a second from Nemec to rescind the Board's vote that approved the Zoning Board recommendation to deny zoning text amendment at its November 16, 2015 meeting. Zoning Board Chairman Jim Kruger was present and briefly reviewed the public hearing on this petition and the Zoning Board's concerns. The trustees discussed possible restrictions on the building construction. Aye: Seiler, Nemec, Finney, Fudala, Ziemba. Motion passed. Seiler moved with a second from Nemec to instruct the Village Attorney to prepare a zoning text amendment to allow outbuildings on lots of not less than 10 or more contiguous acres, with buildings to be no more than 2,000 sq. ft. and no more than 15' high, with no water or sewer utilities. Ave: Seiler, Nemec, Finney, Fudala, Ziemba. Motion passed.
- 2. President Pickett said there will probably not be a state budget for several months yet.

1. <u>Seiler moved with a second from Ziemba to approve Resolution No. 479, "A Resolution Establishing Dates of Regular Board Meetings of the Board of Trustees of the Village of Sleepy Hollow for Calendar Year 2016." Motion passed unanimously.</u>

1. The Board reviewed the ordinance to request a tax increase from the residents in the amount of \$180,000. If approved, this would result in an approximate annual property tax increase of \$66 on a home valued at \$100,000 and \$165 on a home valued at \$250,000. It was noted that the Village will need to request another increase in a few years. Ziemba moved with a second from Finney to approve Ordinance No. 2015-14, "An Ordinance to Provide for the Submission of a Certain Proposition to the Voters of the Village of Sleepy Hollow, Kane County, Illinois at the March 15, 2016 General Primary Election to Increase the Village's Limiting Rate Under the Property Tax Extension Limitation Law for Municipal Purposes for Levy Year 2016." Aye: Ziemba, Finney, Fudala, Nemec, Seiler. Motion passed.

ENGINEER

DIRECTOR OF FINANCE

1. Ziemba moved with a second from Seiler to approve the accounts payable of December 21, 2015 in the amount of \$161,818.93. Chief Linane noted that some of the LESO property could be sold by the Village after declaring it surplus property. Aye: Ziemba, Seiler, Finney, Fudala, Nemec. Motion passed.
