DIRECTOR OF FINANCE

1. Nemec moved with a second from Merkel to approve the accounts payable of January 7, 2019 in the amount of \$92,169.81. Prior to the vote, Merkel requested a copy of the actual invoices from the Village Attorney prior voting to approve the accounts payable. As an accommodation to this request it was agreed that with the exception of the Village Attorney's invoice, a vote to amend the motion to pay all invoices but that of the Village Attorney was made by Merkel with a second from Harney. By a unanimous voice vote the motion to amend was approved. The motion to pay the accounts payable as amended by made would and by roll call vote the motion passed. Aye: Nemec, Merkel, Harney and President Pickett. Nay: None. Approval of the Village Attorney's invoice will be carried over to the next regularly scheduled meeting on February 4, 2019.

WATER AND SEWER

Nemec presented to the board a cost analysis of the current water billing practice (monthly) in comparison to a potential savings if water services were billed on a bi-monthly (every two months) basis. The trustees discussed the concept of changing the billing along with an analysis of the Village charges for related services. No decisions were made and the issue will be carried forward.

POLICE AND PUBLIC SAFETY

Chief Linane presented his December 2018 monthly activity summary report. This data will be included in the 2018 yearly summary once that analysis is completed. In December 2018 police activity on Randall Road was up which resulted in number of accidents being down. The Chief reported as a result of one administrative tow hearing, the defendant offered to turn over his 2018 125cc motorcycle in lieu of paying the fine. As a result the Village now owns the cycle which can either be sold or used for Village activities. Kane County Animal Control notified the Village of a new animal cruelty law 510 ILCA 70/3.01 which allows in part, law enforcement officer to "... take temporary custody of a dog or cat that is a companion animal that is exposed in a manner that places the dog or cat in a life threatening situation for a prolonged period of time in extreme heat or cold conditions" Chief Linane also presented the KCAC data for the number of animals that have been picked up throughout all jurisdictions of Kane County. What is significant is that through the Village's implementation of the Frontline program, KCAC has not picked up a single animal in Sleepy Hollow. This program and practice of the Policy Department has resulted in a substantial savings to our residents and no doubt has made life easier on our pets as well.

Recent coyote reports – a copy of the <u>City of Geneva Coyote Management Plan</u> was given to each trustee for review and consideration. The clerk was directed to rewrite the Coyote Management Plan as the Sleepy Hollow Coyote Management Plan. The revised plan will be presented to the board in the future. It was noted that despite the hysterical reporting on a local website that there has been no report of a coyote attacking a resident and/or a resident's pet and that coyotes are part of rural life in the village.

President Pickett reported he received a 90 day notice letter of intent to non-renew his annual employment contract from Chief Linane. Chief Linane will assist President Pickett to find a replacement but he will retire on April 30, 2019.

Nemec moved with a second from Merkel to adjourn the meeting at 8:29 p.m. Motion passed unanimously.
