## WATER AND SEWER

- 1. The Village is required by the EPA to have a cross connection ordinance. Before the ordinance can be prepared, we need information from ICCI regarding sprinkler systems in the Village.
- 2. Due to issues when Public Works repairs/replaces water meters in homes, an agreement was prepared to be signed by residents prior to the start of water meter work. If, during the course of replacing a meter, something else breaks, Public Works are able to do the work but would have to be compensated for time and materials. After Board discussion, it was agreed that if a resident refuses to sign the Agreement, the Village will not proceed with the water meter work and the resident must hire a plumber to do the work, which work must then be verified by the Village. If a resident refuses to replace a non-working meter, the water will be shut off. Seiler moved with a second from Ziemba to approve the Water Meter Agreement and Release with the dollar amount in paragraph 3 to be filled in by Ellen Volkening. Motion passed unanimously.
- 3. Elgin has raised its water rates to the Village. Seiler moved with a second from Nemec to approve Ordinance No. 2018-1, "An Ordinance Amending the Village Code, Title 6, Chapter 3, Section 9B.1 (Public Ways and Properties/Village Water and Sewer/Water Rates) of the Village of Sleepy Hollow, Kane County, Illinois" but to modify it on page 2, amended B(1), by removing the area regarding sewer customers. Aye: Seiler, Nemec, Merkel, Ziemba. Motion passed.

#### POLICE AND PUBLIC SAFETY

- 1. The Chief updated the Board on several matters: A squad car was involved in a one vehicle accident related to icy road conditions; mega-training of all officers was completed over the weekend; traffic accidents have increased over the past few years, mainly on Randall Road, and are often due to distracted drivers. The Chief also noted that the Department has applied for a grant to enforce distracted driving with federal funds. He briefly reviewed ticket statistics for the past couple years. There was brief discussion of police jurisdiction on Randall Road.
- 2. The Chief discussed the AWT program which will be revised regarding late payments and whether to accept the payment rather than proceed to a court hearing. Mr. Schuster reviewed the options for the Village. Chief Linane said ticket payments that are delivered in person past the due date will be accepted with a \$25 late fee, but those mailed to the Village and received after the 21 day payment period will not be accepted.
- 3. Chief Linane will again speak with the county about a reduction of the speed limit to 45 mph on Randall Road along the Sleepy Hollow portion of the road.
- 4. Minor repairs will be made to the back door of the police department by Elgin Sheet Metal.
- 5. The Chief has not received any resident communications since the last meeting regarding the changes to stop and yield signs in the Village.
- 6. The Chief said the insurance subrogation on the totaled squad car is still not settled.
