This special meeting was called to complete the business of the regular meeting held on June 25th which was cancelled because of an insufficient number of Board Members to form a quorum.

Arthur Lindemann made the motion that the minutes from the May 28, 1959 meeting be accepted as presented. This was seconded by Elmer Houlberg and unanimously carried.

James Jordan next reported that the swimming pool water is to be tested by the State; a report will be available to the Board as soon as the analysis is complete. Mr. Jordan also reported that a safety rope has been installed in the pool for the non-qualified swimmers.

Next an ordinance covering annexation of certain property described in a petition signed by Floyd Falese and Jacqueline Falese was read. On motion made by Elmer Houlberg and seconded by James Jordan roll call vote wasmade as follows:

Alfred Falese made the motion that this ordinance be accepted as presented. This motion was seconded by James Jordan and a roll call vote was made as follows:

Next an ordinance authorizing Northern Illinois Gas Company, it's successors and assignees, to construct, operate and maintain a gas distributing system in and through the Village of Sleepy Hollow, Illinois, was presented to the Board by Mr. Collins for acceptance. Elmer Houlberg made the motion that this ordinance be accepted as presented. This motion was seconded by Arthur Lindemann and aroll call vote was made as follows:

The gas ordinance will be known as Ordinance Number 59-4.

Mr. Pomp of the electric company next suggested that all entrances to the Village of Sleepy Hollow be lighted. This will involve a total of five lamps. The motion to light all entrances was made by Elmer Houlberg and seconded by Alfred Falese. The motion was unanimously carried. Complete specifications of equipment are to be presented prior to installation.

Malcolm McCuaig, Village Attorney, next presented an ordinance hereafter to be known as Ordinance Number 59-1. This being an ordinance making appropriations for corporate purposes for the fiscal year from May 1, 1959 to April 30, 1960 for the Village of Sleepy Hollow. The motion to accept Ordinance 59-1 as presented was made by Elmer Houlberg. This motion was seconded by Arthur Lindemann and a roll call vote was made as follows:

Elmer Houlberg next made the motion that the meeting be adjourned. This motion was seconded by Alfred Falese and unanimously carried. The meeting was adjourned at 9:20 P.M.
