ORDINANCE NO. 67-16

BEING AN ORDINANCE AUTHORIZING TRANSFER OF FUNDS FROM THE WORKING CASH FUND TO THE GENERAL CORPORATE FUND FOR THE VILLAGE OF SLEEPY HOLLOW, KANE COUNTY, ILLINOIS

BE IT ORDAINED by the President and the Board of Trustees of the Village of Sleepy Hollow, Kane County, Illinois:

Section 1. That the amount of \$877.69 is transferred from the Working Cash Fund to the General Corporate Fund.

Section 2. This transfer is made in anticipation of the collection of taxes raised by general taxes on the property situated in the Village of Sleepy Hollow.

Section 3. The amount of taxes extended (or which the Corporate Authorities estimate will be extended) for the year 1966, by the County Clerk upon the books of the collectors of Kane County, Illinois is \$21,926.22.

<u>Section 4.</u> The aggregate amount of Warrants heretofore issued in anticipation of the collection of these taxes, together with the estimated amount of interest which has accrued, is none.

<u>Section 5.</u> The aggregate amount of money heretofore transferred from the Working Cash Fund to the General Corporate Fund in anticipation of the collection of these taxes is \$4,122.31.

Section 6. That this ordinance be in full force and effect upon its passage as provided by law.
