CHANGES TO VEHICLE STICKER FEES

Please be aware of some changes to the way late fees for village vehicle registration stickers will be handled. Beginning next year, a \$5.00 per month per vehicle for late registrations from May 1st to August 31st will be assessed. Starting September 1st, the penalty fee will be \$50 per month and full payment of an AWP ticket will be charged (approximately \$164.00) If payment is still not received at that point, then the next step is court proceedings.

TRUSTEE BIOGRAPHIES

Edward Harney—Trustee of Parks, Roads, and Streets

Ed Harney was appointed to the Sleepy Hollow Village Board to fill a vacancy and was subsequently elected to a four-year term in 2021. Prior to that he served on the Sleepy Hollow Zoning Board of Appeals.

From the Fire Department

Rutland-Dundee Fire Protection District responds to a wide range of calls for service in our communities. From cardiac arrests to house fires – our personnel are trained to provide the highest quality service, whatever the need. The goals of fire response are to suppress hostile fires and protect lives, property and the environment. Our firefighters are highly trained to respond to these fires in a quick and efficient manner. Duties of firefighters during a fire response include:

- **Search and Rescue** firefighters search a building for victims and perform rescues.
- Suppression crews enter a burning building to locate and extinguish a fire. Based on the severity, size, and potential for unsafe structural conditions; crews may be forced to battle the fire from the exterior.
- Command and Safety a commander oversees the operation and ensures firefighter safety.
- Ventilation firefighters cut holes in roofs and remove windows to remove hot gases and smoke so firefighters inside the building can locate and extinguish the fire. Ventilating a building can also provide "good" air for trapped occupants.



- Rapid Intervention Team (RIT) firefighters must stand by to rescue injured or trapped firefighters inside a building.
- **Salvage and Overhaul** firefighters minimize damage to personal items by covering or removing them from the building. They also open walls and ceilings to extinguish fires that could later rekindle.
- **Investigation** investigators determine the cause of the fire.
- Rehab a crew helps firefighters get rehydrated and cooled down after being inside a building.



THE SECRETS OF THE CHURCHILL HOUSE

A resident simply wanting to verify the model name of her home before she put it up for sale, learned that she did not own the home she thought she did. In fact, she was made aware that her home was one-of-a-kind and quite important to the village's housing stock. This information had been lost for well over a decade, and was only rediscovered through research stemming from the resident's verification inquiry. The house in question is located at 721 Pimlico Parkway. The model name of the house is The Churchill, however, it had been confused with and assumed to be a nearly identical Kensington model. All the models in Saddle Club Estates were renamed and slightly modified for 1987, therefore it isn't that uncommon to have model confusion. However, it was not believed that any Churchill homes were built—so it was a huge revelation to find out that a Churchill actually existed. A deeper look through property records not only confirmed that 721 Pimlico was indeed a Churchill, but that it was the only Churchill ever constructed. At 2,288 square feet, The Churchill is the smallest 2-story model offered at Saddle Club.




Saddle Club's Churchill was sold to its original owner in January of 1987 for a cost of \$144,505. According to the original floorplan for The Churchill, its base price was \$139,990 if ownership was taken in 1986 or \$145,990 if ownership was taken in 1987. Given its final cost, it can be inferred that the house was to be completed in 1986 and has \$4,515 worth of options and upgrades, but there may have been a delay or two since it wasn't sold until 1987; or the home was built as an inventory home in 1986 and sat vacant until being sold in January of 1987.

The roots of The Churchill can be traced to the Stonebridge subdivision in Carol Stream. Stonebridge was another

subdivision being built by Pulte Master Builders at the same time as Saddle Club Estates. A model quite similar to The Churchill was being sold there under the name The Buckingham. It is quite apparent that a fresh plan wasn't made for The Churchill. Edits were hand done to The Buckingham's plan to create The Churchill's. This is evidenced by the hand-drawn bathtub in the ensuite and the hand-drawn door connecting the garage to the house as well as redrawn wall where The Buckingham's main floor laundry was removed. (Also note the relocated garage left a white space on the right wall of the dining room and a random stair appears at the back of the garage. Even with The Buckingham's edits, the Churchill's floorplan still isn't 100% accurate. The garage front is shown flush with the house. However, to accommodate the window in the ensuite, the garage needed to be shifted forward. As such, the Churchill's garage sticks out three feet.

Keeping with tradition of Saddle Club's other models, it is assumed that The Churchill was offered in four exterior choices, but with only one constructed, there are no built examples of the other

styles, although the Stonebridge subdivision offers some insight as does Saddle Club's replacement for The Churchill, The Kensington. Saddle Club's Churchill has been extensively remodeled inside and out throughout its tenure with three owners. A Juliet balcony was removed over the front door, a wall was placed in the living room, and the platform bathtub was removed in favor of a large walk-in shower. The kitchen was also reconfigured in the 1990s.



A BRIEF NOTE ON PARK HISTORY

For those curious about historical efforts regarding rehabilitation of Sleepy Hollow's parks, there is a resource available online that outlines a plan that was set forth by Sleepy Hollow in January of 2004. This 51-page plan was written in response to the Green Community Plan initiative and discussed potential changes to Sabatino and Saddle Club Parks as well as other village greenspaces and waterways.

The plans were quite comprehensive, offering amenities on a large scale. Consider the plan's proposal for Sabatino Park; while the 2004 plan exceeded two million dollars in cost, it would've included boardwalks, reforestation, and the addition of a community room at Village Hall. The proposal for Saddle Club Park would've essentially transformed it into a mini version of Sabatino with a perimeter trail, drinking fountain, shelter, and a rain garden. The cost for Saddle Club Park was approximately \$236K. Between a combination of factors such as residential concerns, high price tags, and the fact that the plans weren't intended for immediate implementation, the grand ambitious designs ultimately never came to fruition. Regardless of offering a glimpse into what could've been, the plan provides a basis for some ideas for what could be done in the future (if necessary) on a much smaller scale.

 10% design and engineering fees 	\$18,900

From the Building and Zoning Department

Recently, public hearings were held by the Sleepy Hollow Planning and Zoning Commission (PZC). Compared to past public hearings, the PZC was glad to have a relatively large group of citizens attend the meeting and hearings. During the first public hearing, no one testified; and, during the second, four individuals testified. The testimonies were almost verbatim, and did not provide any supporting details to the individuals' positions that they did not want the proposed subject of the hearing. Unfortunately, this type of testimony did not provide information for the PZC to discuss. The PZC had been working on the subject matters since February.

In the coming months, there may be more opportunities for citizens to attend, and testify, at public hearings. The PZC wants to have citizens participate in the hearings, and to provided details to support the testifier's position, so the commissioners can discuss and consider the testimony given.


To provide clear, concise testimony detailing your position:

- 1) Read and understand what the public hearing is about. Once published, the public notice and, if applicable, the application, are available at Village Hall for you to read. Consider:
 - a. What is the subject of the public hearing?
 - b. What exactly are the plans of the proponent?
- 2) If you decide to present testimony at the hearing, be prepared to provide details supporting your position, whether for or against, a given proposal. Explain:
 - a. How does the proposal affect you personally, or your property in the Village? For example: Consider if traffic passing by your home will increase.
 - b. What suggestions do you have to make the proposal better, to help the Village?

Per the PZC's adopted rules, each individual's testimony will be limited to 5 minutes at any public hearing, and those testifying should be presenting different information. If a group wants to present the same information, a spokesperson for the group should be selected to speak on the group's behalf. Anyone wishing to testify will be need to complete a form identifying themself with name, address, phone number; if acting as spokesperson, also the names, addresses and phone numbers of those individuals being represented.


The PZC looks forward to receiving your constructive testimony at future hearings.

REAL ESTATE VALUES, SPRING AND SUMMER

As you know, the summer edition of The Legend was printed before the spring real estate period ended.
