VILLAGE BOARD MINUTES, JANUARY 7, 1980.

The regular meeting of the Sleepy Hollow Corporate Authorities was called to order on January 7, 1980 at 7:40 PM by President Schoengart. Roll was called and answered as follows: Milz, Mountjoy Peterson, Roberts, Thomas, Zhe, Schoengart present. Also present were Clerk Pofahl, Treasurer Scott, Plan Commission Chairperson Hohner.

The minutes were presented by the Clerk, Mr. Mountjoy moved to accept the minutes, second by Mr. Milz, motion carried by voice vote.

Treasurer's report: Balances, General Funds, \$70,964.56; Revenue Sharing \$808.86; MFT, \$13,778.02; Road Bond Funds, \$4,290.06, Total, \$89,841.50. Receipts, \$6,436.61. Bills Payable, \$8,356.76. Mr. Mountjoy moved to accept the report and pay the bills, second by Mrs. Peterson, roll call: Milz, Mountjoy, Peterson, Roberts, Thomas, Zhe, aye.

West Dundee has requested our support of their funding request for a traffic light at Rt. #31 at Willow Lane. Mrs. Peterson moved to pass Resolution #88 which supports the request, second by Mountjoy, roll call Milz, Mountjoy, Peterson, Roberts, Thomas, Zhe, aye. Mr. Roberts moved to authorize the Clerk to write a letter to West Dundee stating that this light deserves top priority, second by Zhe, motion carried by voice vote.

The President called an executive session to discuss litigation, Thomas vs. Village of Sleepy Hollow.
