Village Board Minutes, May 19, 1980

The regular meeting of the Sleepy Hollow Corporate Authorities was called to order on May 19, 1980 at 7:40 PM by President Schoengart. Roll was called and answered as follows: Milz, Mountjoy, Roberts, Schoengart present. Mr. Thomas arrived at 7:45. Also present were Clerk Pofahl, Treasurer Scott, Attorney Knickerbocker, Plan Commission Chairperson Harlovic.

Mr. Milz moved to accept the minutes of the previous Board meeting, second by Roberts, motion carried by voice vote. Mr. Roberts moved to accept the minutes of the Revenue Sharing Use Hearing, second by Mountjoy, motion carried by voice vote.

Treasurer's report: Balances, General Funds, \$16,633.83; Building Funds, \$33,166.86; MFT Funds, \$19,989.61; Revenue Sharing Funds, \$190.72. Road Bond Funds, \$35,077.42; Total, \$105,058.44. Bills payable, \$1,258.00; Cash received, \$5,537.84. Mr. Roberts moved to accept the Treasurer's report, second by Mountjoy, roll call Milz, Mountjoy, Roberts, Schoengart aye. 0 nays, 3 absent.

Mr. Thomas arrived; the Board Meeting was adjourned to a Budget Hearing on Revenue Sharing at 7:47. Mrs. Schoengart called to order a hearing on Federal Revenue Sharing. The budget was presented, Mrs. Schoengart asked for comments, none were forthcoming. Mr. Milz moved to adjourn the Budget hearing, second by Thomas, motion carried by voice vote.

The regular Board meeting was reconvened at 7:50 PM.

Mr. Roberts moved to appoint John Rabe of 1716 Hickory Drive, Sleepy Hollow to the Finance Committee, second by Milz, motion carried by voice vote.

Mr. Thomas moved to approve the proposed budget for 1980-81, second by Mountjoy, roll call: Milz, Mountjoy, Roberts, Thomas, aye, 2 absent. Mr. Thomas requested that all bills be initialled and the account designated by the trustees.

The Attorney requested an executive session to discuss acquisition of property.

Mr. Milz is to work on the reorganization of the "Cat" ordinance and the "Garbage" ordinance.

Mr. Mountjoy moved to hire Brian Pofahl at \$4.00 per hour to work for the Park and Road Departments. Second by Thomas, roll call: Milz, Mountjoy, Roberts, Thomas aye, 3 absent.

Police training will start May 13 for new part time patrolmen.

Mr. Thomas moved to authorize a change in the payroll schedule to an every-other Friday payday instead of the 15th and last day of the month, second by Roberts, roll call: Milz, Mountjoy, Roberts, Thomas, aye, 3 absent.

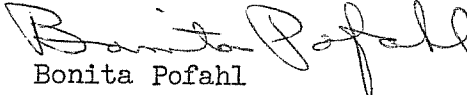
Mr. Thomas moved to pass Ordinance #11-12-A-1 concerning a change in the piston displacement for mini bikes which are allowed in the Village owned land, the change to be from 150 cc to 90 cc, second by Mountjoy, roll call: Milz, Mountjoy, Roberts, Thomas, aye, 0 nays, 3 absent.

Mr. Mountjoy moved to appoint Duane Fleck , 901 Willow Lane, to the Road Committee, second by Mila, motion carried by voice vote.

Meeting adjourned to Executive session, 8:55 PM.

Reconvene at 9:30, roll call: Milz, Mountjoy, Roberts, Thomas, Schoengart present. Mrs. Schoengart appointed a Water Committee to study the billing and bookkeeping procedures, Milz, Chairman, Mountjoy, Thomas, Pofahl, Don Williams of the Plan Commission and Sharon Montalbano, secretary.

Meeting adjourned at 9:35 PM.
