Village Board Minutes, January 19, 1981 7:45 PM

The regular meeting of the Sleepy Hollow Corporate Authorities was called to order on January 19, 1981 at 7:45 PM by President Peterson in the Fire Station. Roll was called and answered as follows: Grisolia, Milz, Mountjoy, Roberts, Thomas, Zhe, Peterson, present. Also present were Clerk Pofahl, Treasurer Scott, Attorney Knickerbocker, Engineer Anderson, Zoning Board Heffron.

Correct minutes of Jan. 5, 1981, Mr. Lewis was not appointed, it was suggested by Mr. Milz that he be appointed. Mr. Mountjoy moved to accept the minutes as corrected, second by Thomas, motion carried by voice vote.

Treasurer's report: Mr. Roberts moved to pay the corrected Advance Construction bill of \$379.52 for additional time spent on repairing the main break at Walnut Hill connection to Hilltop Lane, second by Mountjoy roll call: Grisolia, Milz, Mountjoy, Roberts, Thomas, Zhe, aye. Water Dept. General Administrative: Bills payable, \$8,070.98; Cash received, \$3,033.40. Mr. Thomas moved to accept the Treasurer's report, second by Milz, roll call: Grisolia, Milz, Mountjoy, Roberts, Thomas, Zhe, aye. Water Dept.: Bills payable, \$488.92 plus the Advance bill of \$379.52. Cash received, \$2,502.81. Mr. Milz moved to accept the Treasurer's report, Water Dept., second by Mountjoy, roll call: Grisolia, Milz, Mountjoy, Roberts, Thomas, Zhe, aye. The National Sign bill is OK to pay.

NIPC requested that \$104 be put into our 1981-82 budget.

Appointments: Mrs. Peterson appointed the following people with the advice and consent of the Board--Al Haas and Art Neil to the Zoning Board, terms expire 1983; there are still two vacancies on the Board. John Ward to the Zoning Board of Appeals until 1985; there is one vacancy on this Board. Theresa Peterson as a DAIPC representative. Andrew Lewis to the Water Committee. Mr. Milz moved to accept all appointments, second by Roberts, motion carried by voice vote.

Adjourn to Executive session 10:05PM

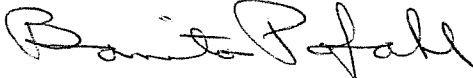
Reconvene, 10:55 PM Roll call: Grisolia, Milz, Mountjoy, Peterson, Roberts, Thomas, Zhe present.
