Village Board Minutes, April 19, 1982

The regular meeting of the Sleepy Hollow Corporate Authorities was called to order on April 19, 1982 by President Peterson at 8:00 PM. Also present were Clerk Pofahl, Treasurer Panning, Attorney Knickerbocker, Chief Bradley, Engineers Whiston and Moulton, Plan Commission Harlovic.

Mrs. Zhe moved to accept the minutes, second by Thomas, carried by voice.

Mr. Roberts moved to pay the bills--General Fund, \$16,029.62, second by Zhe, roll call: Grisolia, Roberts, Thomas, Zhe, aye.

Mr. Roberts moved to pay the Water Dept. bills, \$31,517.83, second by Zhe, roll call: Grisolia, Roberts, Thomas, Zhe, aye.

Mr. Thomas moved to pay Mr. Panning \$5.00 per hour effective May 1, 1982, second by Roberts, roll call: Grisolia, Roberts, Thomas, Zhe, aye.
