## Revenue Sharing Budget Hearing and Village Board Minutes May 17, 1982

Mrs. Peterson called to order the Revenue Sharing Budget Hearing on May 17 at 7:50 PM. Notice of the hearing had been published in the Free Press. Present were Peterson, Grisolia, Rabe, Pofahl, Panning. Revenue Sharing funds amounting to approximately \$13,000 have been budgeted for Police Protection. Hearing closed 7:55 PM

The regular meeting of the Sleepy Hollow Corporate Authorities was called to order at 8:00 PM on May 17, 1982 by President Peterson. Roll call: Grisolia Matthews, Rabe, Peterson; Pofahl, Panning, Bradley, Knickerbocker, Whiston and Moulton.

Mrs. Matthews moved to accept the minutes, second by Rabe, carried by voice.

A flag has been donated to the Village by the Dundee VFW and will be formally presented on May 22 at 10:00 AM in Sabatino Park. Peterson will attend.

Mrs. Peterson appointed Vince Froberg to the ZBA for a 5 year term to end December 31, 1986, Mrs. Matthews moved to concur, second by Grisolia, carried by voice.

The Village will have a Police car in the Dundee Days Parade July 18.

The Engineers will review the wastewater agreement sent to the Village on May 17 by West Dundee. Mrs. Matthews moved to pass Resolutions #111-120 inclusive authorizing the President and Clerk to sign documents pertaining to the design and construction of a wastewater collection system in the Village also the engineering agreement with CMT to be signed and monies paid subject to grant approval from EPA, second by Grisolia, roll call: Grisolia, Matthews, Peterson aye, Rabe abstain. 0 nays, 3 absent.

Residents on Willow west of Bullfrog complained of standing water which was adversely affecting their properties; engineers will study and recommend solution.

Mr. Rabe moved to grant a license to sell beer and a solicitor's license to the Sleepy Hollow Service Club for July 4th activities, also permission for fireworks display, second by Grisolia, carried by voice.

Mr. Thomas arrived 9:00 PM.

The report of the ZBA concerning Harney's request for a variance was presented Mr. Thomas moved to pass Ordinance # 4-41-1 granting a variance for a dog run to Ed and Sue Harney, second by Grisolia, roll call: Grisolia, Matthews, Peterson, Thomas, aye, Rabe absent. Roberts + Zhe absent.

Mrs. Matthews moved to pass Ordinance #10-10-15 --Flood Insurance, second by Grisolia, roll call: Grisolia, Matthews, Rabe, Thomas, Peterson, aye. 0 nays.

Bids for the audit were presented by Fritz Griffin General, \$1800, Water Dept. \$750; Donald McLean, \$2200 General, Water Dept. \$1000.

Mr. Rabe moved to award the bid to Fritz Griffin per quote, subject to legal opinion, second by Thomas, roll call: Grisolia, Matthews, Rabe, Thomas, aye. 0 nays.

Rabe left, 10:05 PM Roberts arrived 10:35 PM


