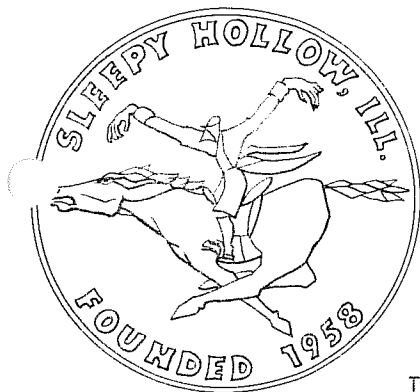

Levy Hearing and Board Minutes, August 16, 1982

Mrs. Peterson called the Levy Hearing to order on August 16, 1982 at 7:15 PM. Notice had been published in the Free Press on August 6, 1982 in accordance with the Truth In Taxation law. Present were President Peterson, Trustees Grisolia, Matthews, Rabe, Roberts, Clerk Pofahl, Treasurer Panning, Attorney Knickerbocker. A large audience was present Mrs. Pofahl and Mr. Knickerbocker explained the taxing process, then questions and comments from the audience were heard. Hearing adjourned at 9:00 PM.

The regular meeting of the Corporate Authorities of the Village of Sleepy Hollow was called to order on August 16, 1982 at 9:00 PM following the hearing on the proposed 1982-83 levy. Roll call: Peterson, Grisolia, Rabe, Roberts, Matthews, Clerk Pofahl, Treasurer Panning, Attorney Knickerbocker, Engineer Whiston, Chief Bradley.

Correction to minutes; date should be July 19 not 16; time of MFT bid opening should be Am not Pm. Mr. Rabe moved to accept the minutes as corrected, second by Matthews, carried by voice.

Mrs. Matthews moved establish the fact that the Board held a first reading of the proposed 1982-83 Levy Ordinance on August 16, 1982, second by Rabe, motion carried by voice. A second reading and final action will take place on September 7, 1982, Tuesday.

Bids for MFT work were presented, they had been opened August 6, 1982. J. S. Riemer, \$19,054.55; Glaze Construction, \$21,019.45. Mr. Rabe moved to award the bid to J. S. Riemer, 837 Winmoor Dr., Sleepy Hollow, subject to approval of sub-contractors by Mr. Rabe and CM&T, with work to start within 7 days after execution of the contract, second by Roberts, roll call: Grisolia, Matthews, Rabe, Roberts, aye. 2 absent.

Treasurer's report: Mrs. Matthews moved to pay bills of \$6,337.50 for Water Dept., second by Rabe, roll call: Grisolia, Matthews, Rabe, Roberts, aye. Mr. Roberts moved to pay bills of \$14,670.07 from the General Fund, second by Matthews, roll call: Grisolia, Matthews, Rabe, Roberts. Mr. Roberts moved to pay bills of \$1,832.60 out of MFT funds, second by Rabe, roll call: Grisolia, Matthews, Rabe, Roberts, aye. 10:30 PM Mr. Rabe left.

Jim Clark and Greg Allen of UCTV presented a report--proposed changes include a survey of subscribers, new stations, supplementary power and a rate increase in February. Workshops on how to use Cable TV camera to produce shows are in progress.

Mr. Roberts moved to pay Jim Schroeder Construction Co. \$255 to repair the roof over the squad room, second by Grisolia, roll call: Grisolia, Matthews, Roberts, Peterson aye. Roberts moved to adjourn, second by Grisolia, adjourn 11:10 PM
