Village Board Minutes, September 7, 1982

The regular meeting of the Sleepy Hollow Corporate Authorities was called to order on September 7, 1982 at 8:15 PM by President Peterson. Roll call: Grisolia, Matthews Rabe, Peterson present; also present were Clerk Pofahl, Treasurer Panning, Chief Bradley, Attorney Knickerbocker, Engineer Whiston.

Correction to minutes, a note mentioning there was no meeting on ~~September~~ ^{August} 2 due to a lack of a quorum. Matthews moved to accept the corrected minutes, second by Rabe, carried by voice.

Mr. Roberts arrived, 8:20 PM.

Dr. and Mrs. Loheide and Ann Mountjoy presented statements and letters and asked the Board to write to the School Board regarding the proposed closing of Sleepy Hollow and Dundee High Schools. Mr. Roberts moved to write a letter to the District #300 School Board requesting that all avenues be investigated, all possibilities explored, all alternatives which have been presented be thoroughly investigated by the administration and reported publicly, second by Matthews, carried by voice vote.

Mr. Rabe moved to pass Ordinance #21-28-9 which is the Levy Ordinance for 1982-83, second by Matthews with the suggestion that the levy for Parks be justified, roll call: Grisolia, Matthews, Rabe, Roberts, aye. 2 absent.

Re: Sewer Agreement--Knickerbocker will talk with Whiston and then to Sommer Peterson will contact Terri Zeal of the IEPA.

Curran Construction Co. will be the sub-contractor for Riemer, Glaze will do Sleepy Hollow Road.

Treasurer: Mr. Roberts moved to pay the General Fund bills of \$5,334.77, second by Matthews, roll call: Grisolia, Matthews, Rabe, Roberts, aye. Mrs. Matthews moved to pay Water Dept. bills of \$4,136.13, second by Rabe, roll call: Matthews, Grisolia, Rabe, Roberts, aye. 2 absent. Mr. Rabe moved to pay MFT bills of \$1,447.09, second by Matthews, roll call: Grisolia, Matthews, Rabe, Roberts aye. 2 absent.

Mr. Roberts moved to put the Red Truck up for sale on closed bids, second by Rabe, carried by voice.

Mr. Rabe moved to adjourn, second by Grisolia, adjourn 11:10 PM
