Village Board Minutes November 15, 1982

The regular meeting of the Sleepy Hollow Corporate Authorities was called to order by President Peterson on November 15, 1982 at 7:40 PM. Roll call: Grisolia, Matthews, Treece, Peterson; also Clerk Pofahl, Treasurer Panning, Chief Bradley, Engineer Whiston.

Mr. Grisolia moved to accept the corrected minutes (Rabe and Thomas arrived at 7:55) second by Treece, carried by voice vote.

Mrs. Peterson reported on the meeting with Homart and West Dundee concerning the proposed annexation by West Dundee of the land north of the Village property on Sleepy Hollow Road and Rt. #72. Mr. Sommers is to prepare a proposal and have it to us by Friday, Nov. 19.

Mr. Rabe arrived 8:00

Mr. Rabe moved to pay Brady Redi-mix for concrete materials for Sleepy Hollow Road per estimate a sum not to exceed \$4200.00 second by Grisolia, roll call: Grisolia, Matthews, Rabe, Treece. (Money from General Fund.)

Mr. Grisolia moved to pay bills from General Funds of \$4,023.95, second by Matthews, roll call: Grisolia, Matthews, Rabe, Treece, aye

Mrs. Matthews moved to pay from Water Dept. funds bills of \$4,903.14, second by Grisolia, roll call: Grisolia, Matthews, Rabe, Treece, aye.

Mrs. Matthews moved to pay the Water bill from Elgin for the month of December when it arrived, second by Grisolia, roll call: Grisolia, Matthews, Rabe, Treece, aye.

Mr. Thomas arrived 8:15

Residents of Locust and Willow Lanes complained of cars racing down Locust at high speeds.

Mrs. Matthews moved to ratify the agreement with Mrs. McCarthy of 1179 Carol Crest Ct. whereby she agrees to pay the \$9 monthly charge for water service, connect to the Village water system by September 1, 1984, and pay for inspection fees, etc. as are required; also to accept her check for \$216.00, ref. letters of October 5 and 19, 1982 between G. Knickerbocker and Dan Curran, second by Grisolia, carried by voice vote.

Mrs. Matthews moved to reimburse John Masek \$50 for his cost of attending Water Operators class at Harper College, second by Rabe, roll call: Grisolia, Matthews, Rabe, Thomas, Treece, aye.

Mr. Rabe moved to approve the final payment on 1982 MFT work to Glaze Construction Co. a total of \$29,801.98 subject to negotiation by Rabe on several items, second by Thomas, roll call: Grisolia, Matthews, Rabe, Thomas, Treece, aye. This amount does not include the base and first coat of sealcoat on Sleepy Hollow Road which had been done incorrectly.

Mr. Grisolia moved to approve signing the 1982 final change order for MFT , second by Matthews, carried by voice vote.

Mr. Rabe moved to cancel the December 20 Village Board meeting, second by Grisolia, carried by voice, Matthews no.

Mrs. Matthews moved to pay a \$25 towing bill for Mrs. Alden, 951 Willow. The barricades had been removed near some roadwork, and her car became stuck.; second by Grisolia, roll call: Grisolia, Matthews, Rabe, Thomas, Treece, aye.

Mr. Rabe moved to adjourn, second by Treece, adjourn 9:45 PM
