Truth In Taxation Hearing			
Village Board Minutes	August 15, 1983		

The Truth In Taxation Hearing was called to order by President Peterson on August 15, 1983 at 7:05 PM. Notice was published in the Free Press on Aug. 5. Present were Peterson, Grisolia, Matthews, Cook, Treece, Pofahl. The proposed levy amounts were discussed. Anticipated income was discussed. Meeting adjourned 7:40 PM

The regular meeting of the Sleepy Hollow Corporate Authorities was called to order on August 15, 1983 at 7:40 PM by President Peterson. Roll call: Cook, Grisolia, Treece, *Matth* Peterson, Pofahl, Chief Bradley, Attorney Knickerbocker, Engineer Whiston.

Mrs. Matthews moved to accept the minutes of the previous meeting, second by Cook, carried by voice. There was no meeting the first Monday in July or August.

During the President's report Mr. Rabe arrived at 7:45 and Mr. Thomas at 8:00.

Levy Ordinance, please attend.

A long discussion on weeds and mowing followed. Mrs Matthews moved that the Village will not mow any lots, second by Grisolia. Amended by Mr. Thomas to add except as deemed necessary by specific Board approval for health or safety reasons, second by Rabe; carried by voice, Treece no, original motion carried by voice, Rabe no. Mr. Treece will inform Arnold and Bill of the decision.

Transfer of land from the Land Conservancy to the Village is in progress.  
Mr. Rabe expressed a concern about the condition of the roads in Walnut Hill and asked the Attorney to pursue the obtainment of a surety bond from the LaSalle National Bank.

Mr. Bohanek discussed his water problems and the lack of water in his "creek". Cook will contact Elgin about testing the water, and possibly flushing will help. Grisolia will make one more attempt to contact Homart about the diversion of the Creek water.

Rabe left 9:00. Bakely is finished, Geske should start Aug. 22.

Treasurer's report: Bills payable--Mr. Thomas moved to pay G&A bills of \$7887.87 which does not include road dept. bills, Mr. Rabe to make the decision on those bills, second by Grisolia, roll call: Cook, Grisolia, <sup>M</sup>Matthews, Thomas, Treece, aye. Rabe absent. Mrs. <sup>M</sup>Matthews moved to pay Water Dept. O & M of \$6664.59, second by Cook, all present aye. Mr. Cook moved to pay Water Dept. DI&E of \$4028.90, second by Matthews, all present aye

Mr. Cook moved to remove the foot bridge over the lake behind Myrna Court, as the rails have been removed by vandals, second by Thomas, carried by voice.

A Stop sign has been proposed for Walnut Hill's Hilltop East into Hilltop Court.

The proposed "teen drinking" ordinance had been tabled until Aug. 15. Mr. Cook moved

to remove it from the table, second by Grisolia, 3 no, 2 yes; motion remains on table. Mr. Thomas moved to table again until a full Board is present, second by Treece, carried by voice, Cook no. Discussion centered on Robert's Rules of Order concerning the Tabling of motions--everyone study your Rules!! *been drinking issue was discussed.*

Motion to adjourn by Treece, second by Cook, adjourn 10:42 PM
