Levy Hearing and Board Meeting August 6, 1984

President Peterson called the Levy Hearing to order at 7:10 PM on August 6, 1984. Present were Mr. Treece, Mr. Cook, Mrs. Peterson and Clerk Pofahl. Notice was published in the Free Press on July 27, 1984. Total request for next year's levy is \$148,700. This year the Village expects to receive \$125,145.00 not including bonds and interest or election expense or Road & Bridge from the Township. The amount requested is down from last year.. Members of the press and the LWV were in the audience. Hearing adjourned 7:25 PM.

The regular meeting of the Sleepy Hollow Corporate Authorities was called to order on August 6, 1984 at 7:35 PM by President Peterson, present were Cook, Rabe, Treece, Peterson, also Clerk Pofahl, Treasurer Panning, Chief Bradley, Roberts 7:40 PM.

Mr. Treece moved to accept the minutes of the previous meeting, second by Cook, carried by voice.

On July 27, Mesdames Matthews and Peterson attended a meeting with representatives of the Elgin Sanitary District, Kane County and the Village of Gilberts regarding the upsizing of the sewer main from the West Dundee/ Elgin connection to the ESD plant. There will not be any upsizing of the line as studies and paperwork would take too long and might jeopardize the ESD grant to expand their plant.

Members of the Falese family were present requesting Village concurrence on a plan to build apartment buildings and duplexes and connect to West Dundee sewer line. There is already a line existing which serves the Winmoor Apartments (Spring Hill Apartments) which is large enough to serve the proposed area. Mr. Roberts moved to concur with the proposed hook up to West Dundee sewer and to write a letter to West Dundee giving Sleepy Hollow's consent to such a plan, second by Rabe, carried by voice.

Mr. Helmut Holze, who owns land immediately adjacent to the Falese land, also presented plans for apartments and requested permission to hook up to West Dundee sewer. Mr. Roberts moved to concur in Mr. Holze's request to ask West Dundee for sewer service, second by Rabe, carried by voice.

The IML has concluded negotiations with IBT for franchise payments, a proposal will be sent soon.

Mr. Treece moved there be no meeting on the third Monday in August, second by Rabe, carried by voice. The next meeting will be on TUESDAY, September 4, the day after Labor Day.

Mr. Treece moved to give Patrolman Gary Schwartz his vacation pay in lieu of his vacation due to financial hardship, second by Roberts, carried by voice.

Mr. Thomas arrived 8:40 PM.

Village Board, August 6, 1984

Treasurer's report: Mr. Treece moved to pay bills of \$16,416.04 from General Fund, second by Roberts, roll call: Cook, Rabe, Roberts, Treece, aye; Thomas abstain.

Mr. Rabe moved to pay bills of \$3,075.69 from Road & Bridge, second by Treece, roll call: all present aye.

Mr. Rabe moved to pay MFT bills of \$28,479.15 subject to Engineer's approval, second by Roberts, all present aye.

Mr. Cook moved to pay bills of \$7661.51 from Water O&M, second by Treece, roll call: all present aye.

Mr. Cook moved to pay bills of \$405.96 from Sewer Fund, second by Treece, roll call: all present aye.

Mr. Cook moved to allot \$100 for postage for water bills, second by Thomas, all present aye.

Planning Commission will meet the last Monday of August.

Work will begin on the drainage problem at Pacchini's residence. The log cabin on Sleepy Hollow road is down, logs are to be used for the salt bin.

Mr. Thomas suggested increasing the amounts for the Levy, the Ordinance will be presented for passage on September 4.

Mr. Treece moved to accept the high bid of \$1256.58 from the Cullen's, if they choose not to accept, to accept the next highest bid; 10 days to be allowed; payment to be in cash, money order, cashiers or certified check, second by Rabe, roll call: Cook, Rabe, Roberts, Thomas, Treece, aye. Letters to be sent to all bidders.

Mr. Roberts moved to purchase a 1984 Chevrolet pickup truck, one ton capacity, with snow plow from Biggers Chevrolet, trade in 1979 Chevy pickup, cash cost \$10,898, second by Rabe, roll call: Cook, Rabe, Roberts, Treece, aye, Thomas no.

The house at 1132 Gail lane has connected to the water system.

Lightning arresters have been installed on the pump house, cost \$300.
