

VILLAGE OF SLEEPY HOLLOW  
MEETING OF JULY 28, 1961

The regular meeting was called to order at 7:30 P.M. by Floyd Falese, Village President.

The first order of business was Roll Call which was answered as follows:

Also present at the meeting was Orville Ohe, Village Treasurer, and Larry Sabatino, Chief of Police.

The minutes of the previous meeting held July 14, 1961 were read and approved as submitted. A donation of inhalator made to the Village of Sleepy Hollow by Suarze Bros. was brought up and it was suggested that Harley Adams write these gentlemen a letter thanking them for the equipment furnished.

The Village Attorney, Francis Crowe was not present due to hospitalization, so the formal Trash Ordinance as approved at the previous meeting was not ready for the Board to act on.

Orville Ohe, the Village Treasurer submitted his Financial Statement dated July 26, 1961. Various bills and statements referred to by the Treasurer were discussed with the Board and approval given where such bills were found to be acceptable.

The question of radar control was next discussed by the Chief of Police, Larry Sabatino and he reported on the reasons for the need of such equipment within the Village. After discussion of the equipment in question, Elmer Houlberg made a motion that the Village purchase said radar equipment. The motion was seconded by Arthur Lindemann and was voted on as follows:


