

MINUTES OF THE BOARD MEETING
VILLAGE OF SLEEPY HOLLOW
MARCH 7th, 1966

The following are the board minutes of the Village of Sleepy Hollow, March 7th, 1966.

The meeting was called to order at 8:00 PM by Floyd Falese, Village President. Roll call was taken and answered as follows:

L. Knott - absent (rpt. present 9:15)	A. Geis - present
R. Fischer - absent	F. Hlavacek - present
A. Lindemann - absent (rpt. present 8:20)	J. Quaine - present

It was decided that the next meeting would be changed from April 4th to April 11th so as not to conflict with the Easter period. Chief Sabatino reported that the new squad car would have a twin bar red light and that the minutes of the previous meeting should so read. The minutes of the previous meeting were read and accepted as read except for the above correction. The Mayor reported that the population of the Village is currently around 1,600. The court case with Carpentersville was discussed. A judgement was rendered that the Village would have to pay \$500.00 payable in three installments, the balance due in full by February 18th, 1967.

Sleepy Hollow Police Association

An expression of thanks was made to Mr. Hlavacek and to Mr. Kessler who donated funds for the purchase of radio equipment to the Village. Mr. Hlavacek read the treasurers report in the absence of Mr. Quigley. A voucher was received from the State of Illinois in the amount of \$4,972.58. Twenty-five dollars was received for ticket violations. A request was made that an open invoice dating back to July to W. R. Meadows be examined.

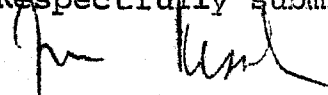
Mr. Quaine reported that the Falese Land Co. had sold eight of the seventeen vacant houses originating from the Mark 60 homes. A discussion was made on having a general village clean-up. Mr. Callahan was present at the meeting and interviewed by the board for the possibility of being hired to do general village maintenance work. It was agreed that he would be paid \$450.00 a month plus extra pay for duties rendered in being a part time policeman. He would be under the supervision of Chief Sabatino. His nature of employment would be on a contract self employed basis. Mr. Quaine moved and Mr. Lindemann seconded and the voice vote of 4-0 approved of Mr. Callahan being engaged by the Village of Sleepy Hollow based on the above terms.

A letter was read by the Park Commission and the board wish^{ed} to express appreciation to the commission for its continuing fine efforts on behalf of the Village. Mr. Geis read the police report.
