

MINUTES OF THE REGULAR MONTHLY MEETING
OF THE VILLAGE OF SLEEPY HOLLOW
August 7, 1967

The following are the minutes of the regular monthly meeting of the Village of Sleepy Hollow, August 7, 1967. The meeting was called to order at 8:00 P.M. by Mayor Falese. Roll call was taken and answered as follows:

The minutes of the July 3 meeting were read. Mr. Baugh made a motion that they be accepted as read. Mr. Quaine seconded. Roll call 4-0, 2 absent. The minutes of the July 15 special meeting were read. Mr. Quaine made a motion that the minutes be amended to read the "purchase of materials" instead of the "payment of materials". Mr. Hills seconded. Roll call 4-0, 2 absent. Mr. Shields made a motion to accept the amended minutes. Mr. Baugh seconded. Roll call 4-0, 2 absent.

Mr. Atkins from Bell Telephone was introduced. He explained the use of certain free telephone service for the village. Ordinance 67-9 was presented to the Trustees. Mr. Baugh moved to adopt the ordinance. Mr. Shields seconded. Roll 4-0, 2 absent.

Mr. Quigley read the treasurer's reports for the months of June and July.

Mr. Hills made a motion to take Village employee, Mr. Miller, off of a monthly rate and to be put on an hourly rate of \$3.75 and to be used when needed. Mr. Shields seconded. Roll call 4-0, 2 absent.

Mr. Baugh motioned to reinstate Chief Sabatino to authorize purchase orders up to \$200.00. Mr. Shields seconded. Roll call, 4-0, 2 absent.

Mr. Baugh read a letter of thanks addressed to the Sleepy Hollow Police Department regarding the help received on the dimestore fire in West Dundee.

Mr. Quaine read Ordinance 67-10, covering builders operating in the village. Mr. Baugh motioned to accept Ordinance 67-10 as read. Mr. Hills seconded. Roll call 4-0, 2 absent.

Mr. Quaine read the building permit report. Mr. Shields made a motion that all village departments and commissions submit before the board one month in advance a request for any funds needed for their operation, with the exception of an act of God. Mr. Baugh seconded. Roll call 4-0, 2 absent.

Mr. Strass gave a brief report on the water company. Mr. Quigley and ^{Shields} ~~Mr. Quaine~~ are to check with Mr. Kessler on the operation of the water company.

Mr. Baugh is to check on the acceptance of Willow Lane to Route 31. Chief Sabatino gave a brief report on the Mutual Aid Pack. He also stated that another full time man was needed. Salary is to be \$485.00 per month to start and to go up to \$525.00 in a year's time.

Mr. Hills motioned to accept one full time policeman at the

salary of \$485.00 per month. Mr. Shields seconded. Roll call 4-0,
2 absent.

Floor was opened for discussion.

Mr. Shields read a letter of congratulations on the July 4
celebration.

Mr. Quaine motioned to adjourn. Mr. Hills seconded. Time
